#### **LOCATION**

Catherine Street is located close to Commercial Road, in central Hereford and close to its range of shopping, leisure and recreational facilities. Close-by is the bus stations, railway station and the hospital.

#### **DESCRIPTION**

42 Catherine Street is a mature end of terrace home which offers a living room, kitchen and two bedrooms with a bathroom on the first floor. At the rear there is a yard area and in more detail the accommodation comprises:

#### ON THE GROUND FLOOR:

#### **Living Room**

3.66m (12'0) x 3.35m (11')

With a pair of sash windows to the front, wall light points, ornate painted fire surround with over mantel and cast iron grate with tiled panels and hearth. Radiator. Stairway off, door to under stair store cupboards and with a door to;

#### Kitchen/Breakfast Area

2.97m (9'9) x 2.59m (8'6)

With a single drainer sink unit, fitted base cupboards with working surface over, eye level cabinets, radiator and wall mounted gas fired boiler. Double glazed window to the rear, door to rear yard and with doors to an airing cupboard with insulated hot water cylinder and door to larder cupboard with fitted shelves.

### **Bedroom 1**

3.35m (11'0) x 2.79m (9'2)

With sash windows to the front, recess, painted cast iron fire surround, radiator and a pair of doors to a wardrobe cupboard with hanging rail with cabinets over.

#### Bedroom 2

2.9m (9'6) (maximum) x 2.64m (8'8)

With sash window to the rear, cast iron fire surround and radiator.

#### **Shower Room**

2.51m (8'3) x 1.17m (3'10)

With shower cubicle with electric shower unit, pedestal wash basin and low level WC. Double glazed window and radiator.







#### **OUTSIDE:**

At the rear of the property, there is a private yard area (approximately 9'5 x 15') which is part enclosed by a brick wall. It is understood that the property has the benefit of a rear pedestrian right of access.


